Dear 2024 CJHRD State Finals Qualifiers and Parents,

Congratulations on your qualification for the 2024 California Junior High Rodeo Division (CJHRD) State Finals Rodeo. The events that you have qualified in for the 2024 State Finals are provided by your district secretary along with a direct link to enter the rodeo via an online portal. Contact your district secretary first with any questions. For stalling and camping questions, not answered in this packet, you may contact Melissa Budden AFTER APRIL 24.

Please print this full entry packet and read through all the information about entries and the rodeo in general before accessing the online entry portal. This important step will help you understand the details, deadlines and requirements and can save you additional fees and duplicate entries. No refunds will be given due to mistakes or duplicate entries, and no refunds will be issued after April 29. There will be a \$25 admin fee for any entries that are incomplete or require changes. The draw will be posted on May 6 on www.chsra.com

Entries for the CJHRD rodeo are only taken via the [online entry portal](#). All entries, stalls, camping and payments will only be taken online. The link to the entry system is included in your qualification email from your district rodeo secretary, as well as posted on the CHSRA website, www.chsra.com. **Entries are open from April 15 through April 19, 8:00 pm. Late entries will be accepted until 8:00 pm on April 20, 2024 with a \$100 late fee.**

In addition to entering online, you are required to submit the following 3 documents (completed and signed) via [Google Form](#) on or before April 26, 2024. **NOTHING IS MAILED**

1. Grade Verification Form/ Concussion Protocol/ Medical Release
2. Most Recent Report Card (Either: March Mid-Term Grade check, trimester 2 or quarter 3 report card)
3. Tehama County Fairgrounds Release of Liability

If these items are not received on or before the deadline, you will be required to pay a \$25 admin fee at check in. If all documents are not uploaded to the Google Form by May 1, you will be removed from the rodeo prior to the draw being completed.

Rodeo Entry Procedures

Entries open on April 15 and close on April 19, 2023 at 8:00pm. (Late entries will be accepted through April 20, 2024 with a \$100 late fine.)

- Payments must be made at the time of entry with either Visa or MasterCard.
- To avoid additional fees or multiple entries, please complete the entry planning form in this packet for your own use before accessing the online entry portal. This step will help to ensure that you have all of the necessary information ready for a smooth and complete entry process.
- Contestants may nominate themselves as an event director for the rodeo on the entry form by typing in the EVENT they would like to be the director for. You must be entered in the event at state finals you are nominating yourself for. Voting will take place via email on a Google Form from May 1-7

Rodeo Check-In

Location: Outside Rodeo Office

Shooting contestants must check in at fairgrounds before arriving at range

Check-in Schedule: Tuesday, May 14, 5:00–7:00 pm (Shooting Contestants should check in at this time)
Wednesday, May 15, 7:30 am – 7:45am (Shooting Contestants Only)
10:00am – 12:00 pm and 2:00 pm – 6:00 pm
Thursday, May 16, 7:00 – 7:45 am

- Contestants must check in at the first check in window once they arrive on grounds
- Contestants are required to know their NHSRA membership number J-CA-000***
- Don't forget to mention your favorite ice cream flavor when you sign in
- Contestants must wear their district vests while checking in at the rodeo and show membership card
- **All contestants must be checked in by May 16, 2024 @ 7:45 am or be disqualified.**

Stall/Pen Rentals

All stalls/pens are reserved and paid for through the online entry portal. Stalling requests must be made on the online entry. Questions: Melissa Budden (call between 8 am - 7 pm AFTER APRIL 24) at (530) 520-8730

- **STALLS MAY NOT BE USED AS TACK ROOMS.**
- **If you are bringing a stallion, reserve a stallion box stall and note “stallion” in request box**
- Contestants may rent the same number of stalls/pens as events qualified in for \$50 each.
- There are box stalls and covered pens. You will need to reserve the type of stall/pen requested. Attempts are made to fulfill requests, but **they cannot be guaranteed.** You must make requests on the entry form
- Only one horse is allowed per stall/pen.

- Covered panel pens will have shavings upon arrival because they are set up on asphalt. None of the other stalls will have shavings at arrival.
- Shavings will be available for purchase on site.
- **Mandatory cleaning-\$100 fine if not cleaned**
 - Box Stalls: Fully clean box stalls of shavings and manure, then dump in designated areas.
 - Panel Pens: Scrape all shavings and manure to the CENTER of pens (NOT AISLE)
- Do not show up with horses if you have not reserved/paid for a stall on your entry

Camping

Camping reservations are made and paid for through the online entry portal. The **length of your trailer/RV is required**, so have the information available when you begin your entry. Requests will only be taken on the entry forms. **If you plan to camp together, YOU MUST ARRIVE TOGETHER.** Questions **after April 24** should be directed to Melissa Budden at (530) 520-8730 (between 8 am and 7 pm).

- At the time of entry, 1 camping spot per family (not per contestant) may be reserved
- RV or Trailer - \$150 per site w/hook-ups (most sites have electricity and water is within reach of filling) **An extra hose and water tee are recommended**
- Dry/tent camping - \$50 per site (Will be parked in different lot)
- Your RV will be checked in when you arrive at Gate 7 off Trinity Avenue. Your assigned camping and stalling locations will be provided at that time. If you want to camp together, you **MUST ARRIVE TOGETHER**
 - Septic pumping is included in camping fee: You will either be serviced Thursday OR Friday, depending on where you are parked
- Horses are NOT allowed in any camping areas, bring wagons to haul your tack

Personal Motorized Vehicles

No motorized gas or e-assist type vehicles are allowed on the grounds. For example: personal golf-carts, motorcycles, scooters, e-bikes, etc. Contestants will be disqualified if a family member, friend, or contestant is using one. Handicapped access or special permits can be requested by emailing Jen Fleming, secretarychsra@gmail.com.

Disciplinary Committee

This committee of state board and district presidents (or designated representative) will meet at 7:00 am before each rodeo to discuss any rule violations (outside of the arena competition rules) that arise with contestants, parents or family members. On Thursday, a representative from districts 1,4 and 7 shall be part of the committee, along with members present from the CHSRA Executive Board. On Friday, districts 2,5 and 8 will be representatives, and on Saturday, districts 3,6 and 9 will serve on the committee. If a member is asked to meet with the disciplinary committee, the member shall have the district president or adult junior high representative present during the meeting as an advocate for the member. Please see attached Disciplinary Committee description for more details

Dress Code

Dress code will be enforced at all times. Please be aware of the areas where full western attire is required for both contestants and associate members.

- Contestants must be in rodeo dress code during the rodeo whether in the arena or in the grandstands.
- Associate members must be in rodeo dress code when helping contestants in or near the arena.
- All contestants are required to wear their district vests and rodeo back numbers at all times whether at the fairgrounds or in the community.

- Any CHSRA Junior High member in good standing may enter, you do not have to qualify at your district. Entry must be completed April 15-19 through the online entry system.

Mandatory Ground Rules Meeting

Thursday, May 16, 8:00 am in grandstands

- Contestants are required to attend (in full dress code)
- Parents are STRONGLY encouraged to attend
- Student and Adult event directors are introduced during the meeting
- District team pictures are immediately following
- Rodeo will start 30 minutes after pictures are complete

Grand Entry

- Each district is required to participate in Grand Entry. Please make sure to have 3-4 contestants who are able to carry sponsor flags safely and we encourage all contestants to participate, even if you cannot carry a flag.

State Event Director and Officer Elections

- Contestants may nominate themselves for an event director position in an event that they are competing in. To do so, their name must be included in the student director section of the online entry form.
- Student members may sign up in the rodeo office by 7:45 am on Thursday, May 16 to run for any state office (President, Vice President or Secretary). Voting will take place from May 16 at noon until Friday May 15, 5 pm. Members may display election posters during the rodeo. However, all posters must be removed before the end of the short go-round. Posters that are not removed will leave the member in "poor standing" for the 2024-25 season. The newly elected officers will be announced at the activity on Friday night. Newly elected officers must participate and carry flags during the short go grand entry on Saturday

Friday, May 17, 8:00 – 10:00 pm Details to be posted later. At least one adult chaperone is required from district 2, 4, 6, 8, 9.

- Chaperone names are due to Jen Fleming no later than Wednesday, May 15th, 5 pm.

Short Go

The top 15 in each event will come back on Saturday for the short go performance. Barrel racing and pole bending are a random draw for the short go. Rough stock will run lowest to highest (scores) and timed events will run slowest to fastest (times) for the short round. (15th-1st)

Awards

The awards ceremony takes place about 60 to 90 minutes after the short go-round. Awards are given to the top ten in each event and based on aggregate times of the 2 long go-rounds and the short round. State finals event champions are determined by the lowest aggregate time or highest total scores regardless of the total points in the events. The national finals qualifying team will be announced at the award ceremony. All Around Cowboy and Cowgirls are awarded on points. See attached table for point scale for All Around Awards ONLY

Silent Auction Item

Each district is responsible for a silent auction table. The theme and item are up to the discretion of the district. NO ALCOHOL may be DISPLAYED with your item. You may have pictures or descriptions. It is your responsibility to get the winner the items. All proceeds go to the Scholarship Fund

Junior High Queen Contest

We will hold a Junior High Division Queen Contest this year. If a district does not have a current junior queen title holder, then the contest is open to any female in grades 5-7, who is a member in good standing with their district and CHSRA. If the district has a current Junior High Queen, only that member from the respected district may enter the state contest. National Team Qualifiers' Meeting – (Top 4)

A **mandatory** contestant and parent meeting for all national qualifiers immediately follows the awards ceremony.

- The NHSRA Junior High Division Finals Rodeo is in Des Moines, Iowa, June 23-29, 2024. If you qualify, **you will need to declare your decision to participate before the awards ceremony.**
- All national finals rodeo paperwork and payments must be completed and turned in to the state secretary, Jen Fleming, at this meeting. Some of the paperwork must be notarized so please have your government ID with you. Notaries will be available on site. National finals rodeo camping and stalling will also be paid with paperwork submission.
- Cash, check or credit card can be used to pay for National Finals fees. Credit Cards will include a 3% processing fee.
- The National Team is determined by the Top 4 placings in the aggregate in each event

Disciplinary Action

CHSRA shall have the right and responsibility to enforce the rules of the National High School Rodeo Association. Action taken may include disqualification, censure, probation, removal, suspension or expulsion. Disciplinary action shall be authorized against any member, contestant, parents or guardian of members or contestants, or any member of the public attending a national, state/province rodeo, district qualifying rodeo or CHSRA sanctioned function. A member or contestant may be subject to all disciplinary procedures due to action of parent or guardian.

In the event that an issue must come before the disciplinary committee, the contestant shall be notified as soon as possible by the person or persons disqualifying the Contestant.

The contestant must have his or her district adult representative with him or her at the meeting. Parents and guardians are not allowed at the hearings.

The following disciplinary committee structure has been established for Junior High Division State Finals for 2024:

This committee of state board and district presidents (or designated representative) will meet at 7:00 am before each rodeo to discuss any rule violations (outside of the arena competition rules) that arise with contestants, parents or family members. On Thursday, a representative from districts 1,4 and 7 shall be part of the committee, along with members present from the CHSRA Executive Board. On Friday, districts 2,5 and 8 will be representatives, and on Saturday, districts 3,6 and 9 will serve on the committee. If a member is asked to meet with the disciplinary committee, the member shall have the district president or adult junior high representative present during the meeting as an advocate for the member.

In the event that the president or designated representative are serving on the committee, another appointed representative (so long as the representative is not the parent or guardian of member) shall stand in with the member as their advocate.

Important Information

- Any CJHRD member in good standing may enter and compete in the shooting match.
- Members must enter using the online entry form, as with all other state finals events. Entries close on the same date as all other state finals events, no sign ups will be held at the rodeo.
- Contestant vest and back number must be worn at all times.
- Contestants must provide rifle and ammunition meeting requirements for this competition.
- Eye and ear protection is mandatory for all competitors while on the firing line.
- Any firearms displayed or brandished in public or at the Fairgrounds will result in disqualification from the CJHRD State Finals Rodeo.
- For Light Rifle Competition Rules, please visit the CHSRA web site at www.chsra.com and download the “National High School Rodeo Shooting Sports Guide.”
- Range is located approximately 25 minutes from Tehama Fairgrounds.
- There may be no potable water available at the range, please plan accordingly. Restrooms are located at range. Plan to bring snacks and a lunch
- Range is a private facility and not available for practice prior to the competition.
- The top 4 placers from the shooting match will be invited to represent California in the national contest at the NJHR Finals, June 23-29 in Des Moines, Iowa. Contestants who qualify for the national team must plan to attend the national team meeting on Saturday after the short-go to participate in the National Team Sign Up. Parents are required to attend this meeting.

CONCUSSION INFORMATION SHEET

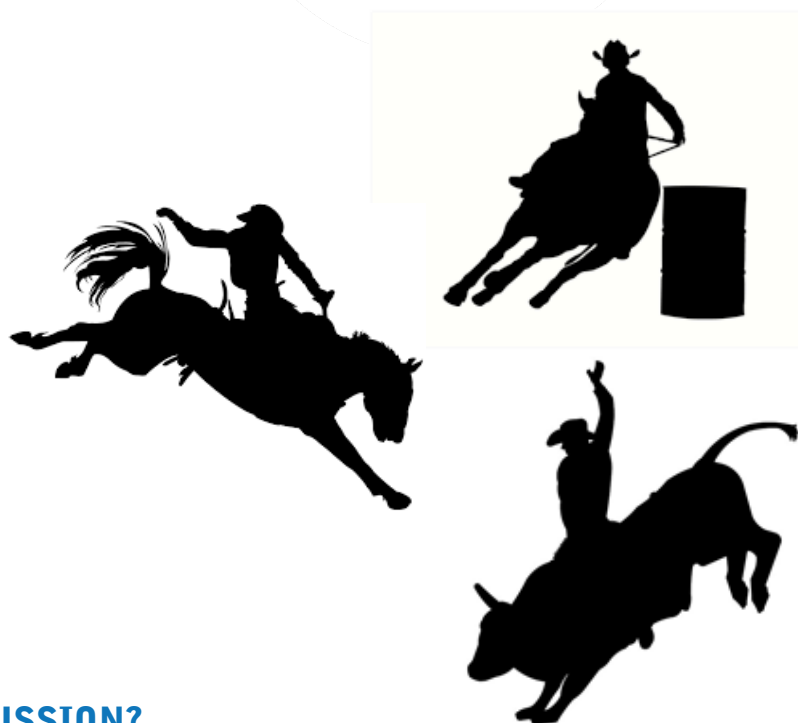
This sheet has information to help protect your children or teens from concussion or other serious brain injury. Use this information at your children's or teens' rodeo, events and practices to learn how to spot a concussion and what to do if a concussion occurs.



**HEADS UP
CONCUSSION**

WHAT IS A CONCUSSION?

A concussion is a type of traumatic brain injury—or TBI—caused by a bump, blow, or jolt to the head or by a hit to the body that causes the head and brain to move quickly back and forth. This fast movement can cause the brain to bounce around or twist in the skull, creating chemical changes in the brain and sometimes stretching and damaging the brain cells.



HOW CAN I SPOT A POSSIBLE CONCUSSION?

Children and teens who show or report one or more of the signs and symptoms listed below—or simply say they just “don’t feel right” after a bump, blow, or jolt to the head or body—may have a concussion or other serious brain injury.

SIGNS OBSERVED BY PARENTS, DIRECTORS OR JUDGES

- Appears dazed or stunned.
- Forgets their turn, is confused about the rodeo or is unsure of an event, time, or score.
- Moves clumsily.
- Answers questions slowly.
- Loses consciousness (even briefly).
- Shows mood, behavior, or personality changes.
- Can’t recall events prior to or after a hit or fall.

SYMPTOMS REPORTED BY CHILDREN AND TEENS

- Headache or “pressure” in head.
- Nausea or vomiting.
- Balance problems or dizziness, or double or blurry vision.
- Bothered by light or noise.
- Feeling sluggish, hazy, foggy, or groggy.
- Confusion, or concentration or memory problems.
- Just not “feeling right,” or “feeling down.”

WHAT ARE SOME MORE SERIOUS DANGER SIGNS TO LOOK OUT FOR?

In rare cases, a dangerous collection of blood (hematoma) may form on the brain after a bump, blow, or jolt to the head or body and can squeeze the brain against the skull. Call 9-1-1 or take your child or teen to the emergency department right away if, after a bump, blow, or jolt to the head or body, he or she has one or more of these danger signs:

- One pupil larger than the other.
- Drowsiness or inability to wake up.
- A headache that gets worse and does not go away.
- Slurred speech, weakness, numbness, or decreased coordination.
- Repeated vomiting or nausea, convulsions or seizures (shaking or twitching).
- Unusual behavior, increased confusion, restlessness, or agitation.
- Loss of consciousness (passed out/knocked out). Even a brief loss of consciousness should be taken seriously.

WHAT SHOULD I DO IF MY CHILD OR TEEN HAS A POSSIBLE CONCUSSION?

As a parent, if you think your child or teen may have a concussion, you should:

1. Remove your child or teen from the rodeo.
2. Keep your child or teen out of their events the day of the injury. Your child or teen should be seen by a health care provider and only return to competition with permission from a health care provider who is experienced in evaluating for concussion.
3. Ask your evaluating health care provider for written release instructions for your child or teen return to rodeo competition.

Do not try to judge the severity of the injury yourself. Only a health care provider should assess a child or teen for a possible concussion. Concussion signs and symptoms often show up soon after the injury. But you may not know how serious the concussion is at first, and some symptoms may not show up for hours or days.

The brain needs time to heal after a concussion. A child's or teen's return to rodeo practice and competition should be a gradual process that is carefully managed and monitored by a health care provider.

HOW CAN I HELP KEEP MY CHILDREN OR TEENS SAFE?

Rodeo is a great way for children and teens to stay healthy and can help them do well in school. To help lower your children's or teens' chances of getting a concussion or other serious brain injury, you should:

- Help create a culture of safety for the team.
 - » Teach ways to lower the chances of getting a concussion.
 - » Talk with your children or teens about concussions and ask if they have concerns about reporting a concussion. Talk with them about their concerns; emphasize the importance of reporting concussions and taking time to recover from one.
 - » Ensure that they follow the CHSRA/NHSRA rules for safety and the rules of the sport.
 - » Tell your children or teens that you expect them to practice good sportsmanship at all times.
- When appropriate for their events, teach your children or teens that wearing a helmet can lower the chances of the most serious types of brain or head injury. However, there is no "concussion-proof" helmet. So, even with a helmet, it is important for children and teens to avoid hits to the head.
